- D) Candidates who have completed Act Apprentice training or job experience for a period of one year or more shall not be eligible.
- E) The candidate who are appearing for required qualification will not be eligible to apply.
- F) The candidate should have the passing certificate/final year mark sheet of the required qualification as on 31.07.2019
- G) The gap between the date of joining and passing date of the qualification for Technician and Graduate Apprentices should not be more than 3 years.
