- 3. Applicants are requested to kindly upload the photograph, scanned copies of all certificates, marksheets, evidence of teaching, research,, Ph.D., NET certificates, copies of reprints of published articles, certificate containing the record of date of birth etc.
- 4. Incomplete application form without scanned signatures and other documents shall be summarily rejected. NIFTEM shall not entertain any correspondence in case of incomplete information and evidences.

5. NIFTEM reserves the right to:

- i. Not to fill up any of the advertised position(s).
- 6. No correspondence regarding consideration of late applications will be entertained.
- 7. The prescribed essential qualifications are the minimum and the mere possession of the same does not entitle candidates to be called for interview. Where the number of applications received in response to an advertisement is large and it will not be convenient or possible to interview all the candidates, NIFTEM, at its discretion, may restrict the number of candidates to a reasonable limit on the basis of qualifications/experience higher than the minimum prescribed in the advertisement.
