**Training period (As per Apprentice Act, 1961): 01 Year**, Reservation is as per Rly. Bd's L.No.-E(MPP)2002/6/10 Date 17.06.2011, the reserved places are SC-15%, ST-7.5% and OBC-27%. If the prescribed number of person belonging either to Scheduled Castes or Scheduled Tribes are not available, then the seats so reserved for them may be filled by persons exchanging the posts between reserved for Scheduled Tribes and Scheduled Castes. If the prescribed seats cannot be filled even in the above given manner then the seats so lying unfilled may be filled by persons belonging to unreserved category. Similarly the seats remaining unfilled by OBC candidates will be filled up by unreserved category. **Last Date**–The last date of receiving of the complete application form in all respects in the office is **10.01.2020 at 17.45 p.m.** by ordinary/Registered post.
