1. Essential Qualification:

Graduate Degree in Science/Forestry

Or Retired Forest Officer not below the rank of Forest Range Officer

2. The Scope of work for expert: Monitoring and Evaluation of CAMPA plantation schemes implemented by Uttarakhand Forest Department. The work will include the following:

- a. Collection, compilation and analysis of field data from assigned Forest Divisions of Uttarakhand
- b. Preparation of the technical report of each division
- c. Act as a coordinator between Uttarakhand Forest Department and FRI.
- d. Submission of reports to FRI in specific time.

3. Forest Divisions in which monitoring to be carried out:

All forest ranges of the allotted forest divisions of Uttarakhand Forest Department and 10% of the area of each site will be monitored. The forest divisions along with site details, methodology, formats etc. will be provided by FRI.

4. Experience:

Applicants must have at least three years of experience of Monitoring and evaluation of forestry and wildlife works implemented by state government/ Central Government. The applicant should have experience of working in Uttarakhand forests and should have knowledge of the geographical area of the state.

A sum of Rs. 30,000/- per month will be paid along with admissible TA/DA entitled for Gr. 'B' officers for the monitoring and evaluation.
