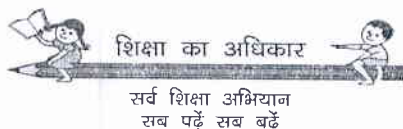

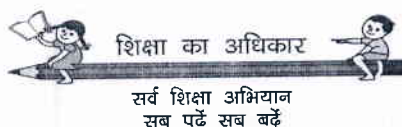

Note: For the above posts of Block Resource Persons, the subject in which STET/HTET has not been held, qualification of holding NET in concerned subject of Post Graduation will be essential. In case both STET/HTET and NET in any subject has not been held by the concerned authority, qualification of STET/HTET and NET will not be required.

Age: The age limit for the above post of BRP is between 18-42 years as on the closing date of application.

Relaxation in Age:

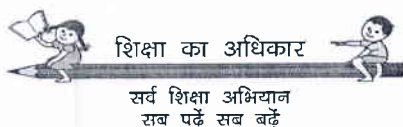
In the case of candidates belonging to the Schedule Caste, Schedule Tribes and Backward Classes, Ex-Servicemen, Physically Challenged and Widows/Divorcee etc. the upper age limit shall be such as may be fixed by the Govt. of Haryana from time to time.

Pay Scale: The incumbent will be appointed in the Pay band/Grade pay of PB-II (9300-34800+GP 4600) Rs. 13860+4600=18460 Per month.

Application Fee: Application fees (non-refundable) amounting to Rs. 500/- for General Category candidates and Rs. 250/- for Female/SC/BC/ESM/PHC candidates of Haryana State will be pay online after filling of application.

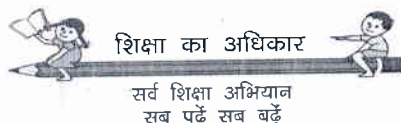

Note:- In case of two or more candidates are having same score as per selection criteria, then a candidate having higher score in HTET/STET will rank higher in order or merit. Further, in case two or more candidates are having same score and same score in HTET/STET, then a candidate having higher score in Essential Qualification will rank higher in order of merit.

2. Written test consisting of objective and subjective type will be conducted.

- The objective type will be of 50 marks, consist of General Knowledge, Mental Ability (Reasoning & Quantitative Technique), Child Development and Psychology, Hindi and English (Matric level) and duration of the paper will be 1 hours.
- The objective type test of the concerned subject i.e. Hindi, English, Mathematics, Science and Social Science of graduation & post graduation level will be of 50 marks and duration of the paper will be 1 hour.
- Minimum scores of 45% for SC/PH and 50% marks for others in aggregate in accordance is required for selection.

3. A qualifying test regarding IT skills and effective use of new technologies as tools for learning will be conducted of 30 marks consisting of 30 multiple

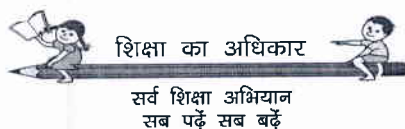
choice objective type question and each question will carry one mark. Each candidate must qualify this test by obtaining 33 % marks and weightage of the marks obtained in qualifying test will not be given while preparing the final merit list. Those candidates who will not qualify this test, their qualification of the above said examination of the objective type of General Knowledge, Mental Ability (Reasoning & Quantitative Technique), Child Development and Psychology, Hindi and English (Matric level) and objective type test of the concerned subject i.e. Hindi, English, Mathematics, Science and Social Science of graduation & post graduation level will not be considered for the appointment.

4. Professional Training Diploma or Certificate awarded by any State, Board of University other than Haryana Education Department must be recognized by the Haryana Government. The candidate is required to submit the Equivalency Certificate at the time of verification of documents.
5. Reservation in SC, BC, ESM, Sports Person and PHC is only for Haryana State. The SC/BC/PHC candidates are required to submit SC/BC/PHC certificate duly issued by the competent authority at the time of documents verification. Likewise, the Eligible Sports Person (ESP) shall be required to submit the sports gradation certificates at the time of documents verification as per Government instructions duly issued by the competent authority, DESM shall be required to submit the fresh Eligibility Certificate duly issued by the respective Zila Sainik Board at the time of document verification).
6. Candidates applying for a post must ensure that they will fulfill all the eligibility conditions on the date of advertisement. If on verification at any time before or after the written examination or interview or appointment, it is found that they do not fulfill any of the eligibility condition or it is found that the information furnished is false or incorrect their candidature/appointment will be cancelled.
7. Candidates having qualified certificates of HTET/STET conducted by Board of School Education Haryana, Bhiwani only will be eligible.
8. A 33% posts in each category i.e. General/Open Competition (OC), Scheduled Caste (SC), Backward Class(BC) and Physically Challenged (PHC) etc. shall be reserved for women. This reservation shall be horizontal.
9. Physically Handicapped Candidates means Physically Challenged Persons with Disabilities as per Haryana Govt. instructions.
