Note:- The numbers of vacancies are subject to variation. Candidates from Other Category (UR, OBC & SC/ST) will also be allowed provisionally to apply against EWS vacant. If EWS category not filled, then the post will be filled on merit basis from candidates belonging to General/Other category on ad-hoc basis.

Horizontal Reservation:

Three (3) posts reserved for Persons with Disabilities category (OA/OL) from amongst the posts of Senior Residents in the non-surgical departments i.e except in the department of **General Surgery, Orthopedics, Obstetrics & Gynaecology, Ophthalmology & Surgical Gastroenterology.**

- *OL - One leg affected (R and/or L),
- *OA - One arm affected (R or L) - (a) impaired reach
(b) Weakness of grip
(c) ataxia

The minimum degree of disability should be 40% (Benchmark Disability) in order to be eligible for availing reservation for persons with specified disability. The Percentage of the candidates' disability will be assessed by JIPMER Medical Board and the decision of the JIPMER Medical Board will be final in this regard.

The candidates applying under the category 'Persons With Disabilities' for the above said posts are exempted for payment of application fee.

PAY SCALE:

The candidates with Postgraduate Medical Degree recognized by the Medical Council of India will be paid **B/Pay Rs.67700/ (Level -11 and Cell-1)** (Revised) and other usual allowances per month (**Total Rs.1,10,000/-**approximately)

ESSENTIAL QUALIFICATIONS:

A MCI recognized postgraduate Medical degree viz. **MD/MS/DNB** in the respective discipline from a recognized University/Institute (Candidates who are completing MD/MS/DNB degree on or before 31st July 2020 are also eligible to apply).

Candidates with **DM/M.Ch.** in concerned specialty will be preferred in respective Super specialty departments as applicable.

Note:

If candidates i.e., MD/MS/DNB are not available/eligible in any particular specialty, those who are having 02 years recognized Post Graduate Diploma after M.B.B.S in the concerned specialty can be considered.

Age Limit:

- **Not exceeding 45 years of age as on 31.07.2020.**

Age Relaxable for Scheduled Caste & Scheduled Tribe candidate up to a maximum period of five (5) years, for OBC candidates up to a maximum period of three (3) years.

In case of Persons with Disabilities (PWD's), age relaxation upto a maximum period of ten (10) years for General Category, Thirteen (13) years for OBC category and fifteen (15) years for SC/ST category candidates.

Persons suffering from not less than 40% of relevant disability shall alone be eligible for reservation, fees exemption and age relaxation.

SELECTION PROCEDURE:

1. In case if more number of applications received, then the competent authority may shortlist the candidates for interview. The shortlisting is based on criteria fixed by the competent authority.

In the first instance, all the candidates who fulfill minimum eligibility in respect of age, educational qualifications and experience (wherever required) are short-listed. If this number is high and it is not possible to call all of them for interview, the competent authority further shortlists the candidates on the basis of some suitable shortlisting criteria as may be fixed by the competent authority. Though this may vary from case to case depending on merits, the competent authority generally prefer to call candidates with higher experience in the relevant fields or candidates with higher educational qualification as the case may be.

The purpose of shortlisting candidates is to restrict, to a reasonable limit, the number of candidates to be called for interview keeping in view the number of posts available at a time, the number of candidates satisfying the Essential Qualifications and other conditions prescribed.

2. Selection process for the post of Senior Resident will include review of academic, research credentials including publications, academic awards, research paper, presentation in conferences and performance in personal / video conferencing interview.

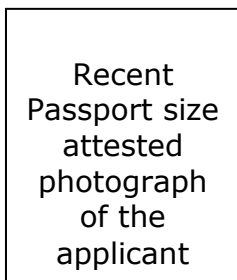
